- Goods every kind of movable property other than money and securities
- ☐ Service anything other than Goods
- ☐ India proposes dual GST model federal structure CGST & SGST
- ☐ Internationally, GST was introduced first in France and now more than 160 countries have introduced GST

#### What is CGST, SGST?

CGST/SGST shall be levied on all *Intra-state* supplies (within state supplies) of goods & services

## What is IGST?

IGST shall be levied on *Inter-state* supplies (between two states) of goods & Services
